It is for information of the all candidates/Aspirants who wish to apply for the post of School Assistant (Physical Education) that in view of the orders of The Hon'ble High Court of judicature at Hyderabad in W.P No.37296 of 2017dt 24/11/2017 , the Government have decided to implement the orders of the Hon'ble High Court by taking erstwhile 10 districts as local area instead of 31 Districts, by readjusting the vacancies with respect to each of the erstwhile 10 districts . Accordingly Government issued amendment to Rules and issued G.O.Ms.No. 33 School Education (General) Department, Dt: 11/12/2017 in this regard.

In view of the above the following Corrigendum (Errata) is issued for information of the candidates.

However their district information in the application forms already submitted have to be changed as per 10 Districts. The “District Edit as per 10 districts” will be available from 15/12/2017 to 26/12/2017 on the website.
